For this reason, if you wish to have comments included in the rulemaking file, or to require the Department to respond to them as part of the process by which it adopts these regulations, you must present your comments during the formal public comment period according to the procedures outlined in the Notice of Proposed Action at the time that document is issued, regardless of whether the comments have been made in connection with this prenotice public discussion. The Commissioner nonetheless welcomes your participation in this discussion and hopes that the regulations that may subsequently be proposed will benefit from your input.
